7. CONTINUED PUBLIC HEARINGS

A. 606 Spring Point. AR 13-279, NC 13-103, Variance 13-75. A request to demolish/remodel an existing single-family house on an R-20,000 zoned lot, and build a new/remodeled 5,633 square foot house and attached 489 square foot garage. Recommendation: Continue to a date uncertain pending submittal of a complete application.

8. NEW PUBLIC HEARINGS

A. 1271 Lemon Avenue; Conditional Use Permit 13-001 A request by California American Water (Cal Am) to install a new pump at an existing well. The Planning Commission conducted a public hearing regarding this request in October 2013 and directed the applicant to prepare a landscape plan for the site prior to further consideration of the CUP. The landscape plan has been prepared and will be discussed at this hearing. Recommendation: Approve project with conditions.

B. 425 Mount Olive Drive; Architectural Review 14-004; Neighborhood Compatibility 14-002; Variance 14-02 A request to construct an addition and undertake a complete architectural remodel to an existing single-family house in the A-2 zone. Recommendation: Open public hearing and provide comments on the application, direct staff to prepare a resolution with conditions, continue hearing open to May 28, 2014.
