2. **PUBLIC HEARING - First Reading of Ordinance No. 309: an Ordinance of the TAB 2  
City Council of the City of Bradbury Amending the City Council Reorganization  
Process for the Appointment of Mayor and Mayor Pro-Tem (Bradbury Municipal Code  
Article II, Chapter 1, Section 2105)**  
The City Council requested an opportunity to review and discuss the process for the selection and rotation of Mayor and Mayor Pro-Tem. It is recommended the City Council open a public hearing and read for the first time by title only Ordinance No. 309.
  
3. **DISCUSSION - Royal Oaks Elementary School Traffic Congestion TAB 3**  
At the request of several residents surrounding and the Principal of Royal Oaks School the Cities of Bradbury and Duarte have been requested to work together to review solutions for the traffic congestion that occurs during drop-off and pick-up times. Staff has been working with the City or Duarte and the City Engineer on various alternatives. Those alternatives include re-striping, specified turn lanes, additional parking spaces and drop-off zones as well as time locked gates at Gardi Street and Royal Oaks Drive. It is recommended the City Council review and discuss this item and provide further direction to staff.

The City of Bradbury has received a request from the Bradbury Estates Community Services District (CSD) requesting that the City amend its contract with Burrtec Waste Services to ensure compliance with CSD Ordinance No. 5. It is recommended that the City Council adopt Resolution No. 09-30 approving Amendment No. 2 to the Agreement between the City of Bradbury and Burrtec Waste Services for Solid Waste Collection and Establishment of a flat fee for scout service in the Bradbury Estates area.
