SMART Composting Workshop - March 12th

Residents are encouraged to attend a free Smart Gardening workshop hosted by Los Angeles County Public Works, the City of Duarte and the Los Angeles Regional Agency (LARA) on Saturday, March 12, 2011 at Mount Olive Alternative School located at 1400 Mt. Olive Drive beginning at 10:00 am. No reservation needed for the simultaneous workshops offered in both English and Spanish. Beginning workshops last about 1.5 hours and provide hands-on instruction on composting, worm composting, grass-cycling, and water-wise and fire-wise gardening.

Mount Olive School is also the site of the award winning "MOOSE" project teaching Duarte youth new ways to think about the environment and green careers. Fireplace Safety



While fireplaces often conjure up images of warmth and comfort, they also represent a significant source (36%) of home heating fires. Creosote - a sticky, oily, combustible substance created when wood does not burn completely - rises into the chimney as a liquid and deposits on the chimney walls, and plays a role in nearly one-fourth (23%) of all home heating fires each year.

The nonprofit National Fire Protection Association (NFPA) and the U.S. Fire Administration (USFA) are teaming up to reduce the risk of these and other home heating fires during the winter months, when half of all U.S. home fires occur. As part of their joint fire safety campaign, "Put a Freeze on Winter Fires," both organizations say that chimneys should be inspected and cleaned annually by a qualified professional.

Keep anything that can burn at least three feet away from a fireplace, wood stove, or any other heating equipment, and create a three-foot "kid-free zone" around open fires. Also, make sure the fireplace has a sturdy screen to stop sparks from flying into the room, and never leave a fireplace fire unattended, particularly when children are present. Ashes should be cool before putting them in a metal container, and kept at a safe distance from your home.

The City Council met on January 18th and took the following actions:

- Final Acceptance of the Mount Olive Sewer Project
- Approved a Memorandum of Understanding with the San Gabriel Valley Council of Governments for the Southern California Edison (SCE) California Long-term Energy Efficiency Strategic Plan (CEESP) Grant
- Adopted Disaster/Emergency Accounting Policy
- Approved the release of performance bonds for two residential construction projects
- Held a public hearing regarding an appeal for the 165 Circle Drive project which was sent back to the Planning Commission for further review
- Held a Public Hearing and read for the first time by title only Ordinance No. 319 adopting and approving the Los Angeles County versions of the 2010 California Building, Electrical, Plumbing, Mechanical, Fire, Residential, Housing and Health Codes and Green Building Standards Code.
- Approved of Plans and Authorized the receiving of formal bids for the Mount Olive Drive and Lemon Avenue Resurfacing Project
- Approved a contract for Professional Landscape Design services for the Civic Center remodel project to Armstrong and Walker Landscape Architecture
- Approved a budget of \$65,000 for the interior finishes and equipment and authorization to solicit for bids and incur costs for office furniture, window coverings, audio visual equipment and information technology equipment for the Civic Center facility
