

ORDINANCE NO. 310

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRADBURY AMENDING THE MEETING TIME OF REGULAR PLANNING COMMISSION MEETINGS (BRADBURY MUNICIPAL CODE ARTICLE II CHAPTER 4 SECTION 2412)

THE CITY COUNCIL OF THE CITY OF BRADBURY DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The Bradbury City Council considered the subject matter hereof as part of its October 20, 2009 Regular Meeting and finds, determines and declares as follows:

A. It is in the best interest of the City to amend the time of Planning Commission Regular Meetings for purposes of generating more community involvement in the meetings and to better accommodate the schedule of City staff and officials.

B. In order to change the Regular Meeting time of the Planning Commission it is necessary to amend Bradbury Municipal Code Article II, Chapter 4, Section 2412.

SECTION 2: Effective December 18, 2009, the following Section of the Bradbury Municipal Code is amended to read as follows:

**ARTICLE II - ADMINISTRATION
CHAPTER 4 – DEPARTMENTS, BOARDS AND COMMISSIONS OF THE CITY**

2412- Commission Meetings.

There shall be one regular meeting of the Planning Commission during each calendar month and such meeting shall be held on the fourth Wednesday thereof at the hour of 7:00 p.m. provided, however, that if the date of any such regular meeting falls on a holiday, said regular meeting shall be held at the hour of 7:00 p.m. on the next succeeding day which is not a holiday.

SECTION 3: If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 4: The City Clerk shall certify as to the adoption of this ordinance and shall cause the summary thereof to be published within fifteen (15) days of the adoption and

shall post a certified copy of this Ordinance, including the vote for and against the same, in the office of the City Clerk.

SECTION 5: This Ordinance will become effective on the thirty-first (31st) day following its adoption.
